ENROLLMENT CONTRACT

_____ I/We have read the parent handbook front to back and fully understand our parent responsibilities including sending our child appropriately dressed for the weather every day.

_____ I/We understand that Trillium Christian Nature Preschool is a faith based school using Christian resources and Bible based curriculum. I/We agree that my child will hear and learn Bible stories and memorize scripture from the Bible.
